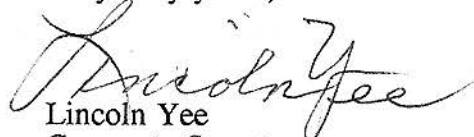

Dear Mr. Goodman:
