handling the matter for me.

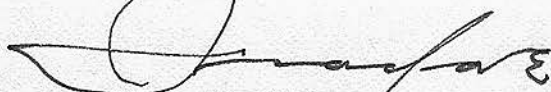
I feel that the settlement was extremely fair and hope
